The subject property has an area of 0.020 ha, depth of 20.617 m and frontage of 10.059 m along the north side of Luton Street.

In the matter of Section 45(1) of The Planning Act R.S.O 1990, the Municipality of Dutton Dunwich Comprehensive Zoning By-law 2004-24, and an application for **Minor Variance MV 05/20**.

The purpose of the minor variance is to request relief from Section 12.1.5 of the VR1 Zone to increase the maximum lot coverage from the required 35 % to 52.6 % for the lot (see attached Sketch). This will permit a 34.06 m2 deck and 6.50 m2 shed.
